1. Winter Storage Term (WST), monthly storage charge and minimum charge:

Grove Services, Inc. d/b/a Acme Cycle Chicago ("Acme") will store the above listed vehicle ("Vehicle") for its Winter Storage Agreement term ("Winter Storage Term" or "WST"): **Winter Storage Term begins on 11/1/2022 and Winter Storage ends on 4/15/2023.** If mutually agreed during the Winter Storage Term, this Winter Storage Agreement can be extended via email to contact@acmecyclechicago.com.

Winter Storage Agreement pricing for storing Vehicle is \$_____ per month. Storage pricing after the end of WST will strictly accrue at \$12/day for all calendar days, (which is the same rate for storage of repaired Vehicles), unless agreed in this Winter Storage Agreement or via email to contact@acmecyclechicago.com. Each monthly storage fee shall become due and payable on the 1st day of each month.

Any Vehicle that is returned to the owner prior to the end of the WST is subject to a minimum Vehicle storage charge of 4 times the monthly Vehicle storage charge, or \$180, whichever is greatest.

2. Vehicles left beyond contract terms:

_____ Any Vehicle stored during the above-defined WST, and is left in storage after the end of the WST shall pay \$12/day for all calendar days, unless mutually agreed upon via email to contact@acmecyclechicago.com.

Notwithstanding the Paragraph above, a Vehicle will be considered abandoned by Vehicle owner and Acme if it is left 90 days beyond the end of the above-defined WST and have a past-due balance in excess of \$100.00.

3. Owner's choice of payment options (initial please):

_____ A) Credit card payment. Vehicle owner may grant pre-approval to run the credit card on file to pay for the upcoming month's storage on or about the 1st of each month; or

_____ B) Cash payment. Vehicle owner opts for payment by cash, tendered to Acme's place of business no later than the 3rd of each month.

4. Removal at end of WST (initial please):

_____ As a courtesy, Vehicle owner agrees to give Acme 3 business days notice via email to prepare the bike for pickup at the end of the WST.

5. Limited In/Out of Bike during WST (initial please):

7. Default

Owner will be in default if s/he becomes past-due in payment in any month's storage or late fees not paid by the 15th of the month in which such fees became due, Acme will have the seek its remedies under Illinois Law, including, but not limited to 770 ILCS 45 et seq or 770 ILCS 50 et seq. Additionally if there is a default, Acme shall be awarded reasonable attorney fees for any legal services connected with collection of rents and fees due, or creating and/or foreclosing any lien established under Illinois Law.
